Introduction

This work instruction provides a comprehensive guide for completing the Supplier Registration Questionnaire required to become a registered supplier for VISA. It outlines the steps and requirements to ensure accurate and complete submission through the Ariba Business Network.


You will learn how to:

- Access your Ariba Business Network account and locate the Supplier Registration Questionnaire landing page.
- Fill out the General Information section.
- Respond to Legal and Additional Information sections, including compliance with the VISA Supplier Code of Conduct.
- Provide accurate Tax Information and Diversity Information.
- Enter Bank Account details, including country-specific requirements and mandatory fields for vendors.
- Identify and input required ID numbers and Accounts Receivable contact information.
- Complete and submit the questionnaire, including how to handle errors while submitting.
- Update information when necessary, after submitting a supplier registration questionnaire.

Ariba Business Network Account

Once the Data Maintenance approver sends the invitation to register via email, as the supplier, you will need to follow certain steps to complete the registration process.

1. Check your registered email and select the invitation email.



2. Select the Click Here button found at the bottom of the email to create an account.




3. You will be redirected to the Ariba landing page where you can create a new account by clicking Create new account.






1. Sign in to your SAP business network, open the Business Network menu, and select Ariba Proposals and Questionnaires.



2. Select the Supplier registration questionnaire under the Registration Questionnaire section.



3. The questionnaire contains six events under Event Contents for which you are required to review or provide information.

If the data entered is incorrect when submitted, an error will appear at the top of the page indicating both the number and location of errors.





- The State/Province/Region field must contain no more than 6 characters.
